- 1 The name of the Federation is **THE DEVON MOORS FEDERATION**
- The names and categories of the schools in the Federation are:-

CHITTLEHAMPTON CHURCH OF ENGLAND (VA) PRIMARY SCHOOL

COPPLESTONE PRIMARY SCHOOL

(Foundation)

FILLEIGH PRIMARY SCHOOL

(Foundation)

(Community)

SPREYTON PRIMARY SCHOOL

(Foundation)

- The name of the governing board is "THE GOVERNING BOARD OF THE DEVON MOORS FEDERATION".
- 4 The governing board shall consist of:
 - a two parent governors;
 - b one local authority governor;
 - c one staff governor;
 - d one executive headteacher;
 - e four foundation governors (one of whom shall be ex-officio) see 7 (a) and 7 (b) below;
 - f three co-opted governors.
- 5 Total number of governors is twelve.
- The term of office for all categories will be for four years with the exception of the ex-officio foundation and headteacher categories by virtue of their office.
- 7(a) Two foundation governors shall be appointed by the Exeter Diocesan Board of Education, one of whom shall be ex-officio.
- (b) Two foundation governors shall be appointed by the United Schools Learning Partnership.

8 (a) The holder of the following office shall be an ex-officio foundation governor:

The Principal Officiating Minister.

- (b) The Archdeacon of Barnstaple shall be entitled to appoint a foundation governor named in 7 (a) to act in the place of the ex-officio foundation governor whose governorship derives from the office named in 8 (a) above, in the event that the exofficio foundation governor is unable or unwilling to act as a foundation governor or there is a vacancy in the office by virtue of which his/her governorship exists.
- 9 Exeter Diocesan Board of Education shall be entitled to request the removal of any ex-officio foundation governor and to appoint any substitute governor, in consultation with the Archdeacon named in 8 (b) above.
- 10 Chittlehampton Church of England (VC) Primary School was founded by Trust Deed.
- 11 Ethos Statement:

Chittlehampton C of E (VC) School is a Church of England school in the Diocese of Exeter.

Recognising its historic foundation the school will preserve and develop their religious character in accordance with the principles and practice of the Church of England and in partnership with the Church in the parishes and the diocese.

The school aims to serve its community by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experiences they offer to all their pupils.
